The Spiritual Church of Turlock (AKA - The Spiritual Science Church #4) and Producer Gaylene Cornell

Booth space sizes and prices: Sizes are APPROXIMATE

- \$150 - 10' X 10' Wall booth (only wall booths have electricity)**
- \$140 - 10' x 10' Center booth**
- \$85 - 6' wide x 10' deep Wall booth**
- \$75 - 6' wide x 10' deep Center booth**

1. Pop-Up/EZ-Up tents are allowed as long as they fit into your space and do not interfere with any of your neighbors booths. ALL Canopies must be removed for fire regulations.
2. You must provide your own tables and chairs. If needed, we can rent table and chairs for you at a cost of \$10 for each table w/chair from the fairgrounds. Canvas/Pop-Up/EZ-Up tents are allowed as long as they fit into your space and do not interfere with any of your neighbors booths. ALL Canopies must be removed for fire regulations.
3. **Set-up time:** Saturday 8:00 AM. The Expo is open from 10:00 AM - 6:00 PM. NO early Breakdown and must be complete by 7:00 PM. **All booth fees are paid prior to the event & are non-refundable.**
4. The Spiritual Church reserves the right to determine the eligibility of any product, company or service. The judgment shall be final.
5. The Spiritual Science Church and producer Gaylene Corenell are NOT liable for personal injury to vendors, their clients, or lost, broken or stolen goods.
6. Exhibitor is financially liable for any damage caused to booths, equipment, or to any Exhibit Hall property caused by the exhibitor.
7. Exhibitor agrees to indemnify and save/hold harmless the event, the Spiritual Science Church No. 4 including all members of that Church, the producer, management, & its employees from any & all claims, causes of action, &

suits accruing or resulting from any damage, injury, or loss to any persons, including, but not limited to persons to whom the Exhibitor may be liable under any Workers Compensation Law & the Exhibitor himself, and any other party related to their exhibition rental including attendees, employees, guests, other exhibitors or members of the public, & from any loss, damage, cause of action, claims, or suits for damages or merchandise, caused by, rising out of, or in any way connected with the exercise of the Exhibitor privileges granted herein.

8. All Federal, State, & City laws pertaining to fire & safety must be adhered to. (**No open flames or lit candles are allowed as per City**)

9. Exhibitors are responsible for meeting all City/County/State resale, licensing, & Health Dept requirements. In the event that any outside force that is beyond the control of The Spiritual Science Church No. 4, such as war, fire, or act of God, prevents the event from taking place, The Spiritual Science Church reserves the right to retain Exhibitor payments to cover expenses.
10. Booth sales are final and non-refundable. By signing this contract you are giving permission to use your photo or video or any type of media including your booth space and products in "any future advertising done by The Spiritual Church of Turlock. **NO BOOTH SHARING ALLOWED!**

Exhibitor acknowledges that this contract shall apply to all future fund raisers, Expo's and or events produced or sponsored by The Spiritual Science Church (The Spiritual Church of Turlock) or Gaylene Cornell in which exhibitor participates. Prices, booth sizes and Venues may change for each event.
